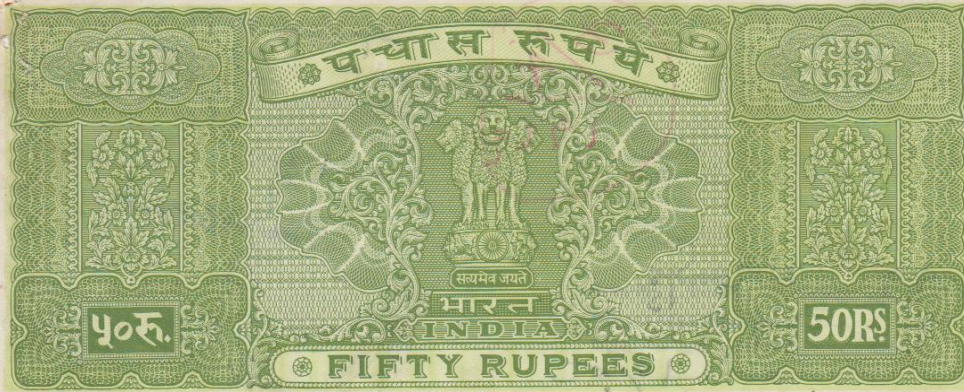





9) For the purpose of carrying out the objects of the Trust, the Trustees shall be entitled to purchase and/or to construct one or more building or buildings of the purchase other immovable property or properties suitable for the functioning of the project. The Trustees shall also be entitled to purchase or acquire furniture equipment and all other movable properties as may be necessary of proper for maintaining and conducting the project and for providing the facilities and undertaking the activities at such places as may be decided upon and otherwise to give effect to the objects of the Trust.

10) The Trustee shall invest the Trust Fund and its income as may not be required or necessary for the purpose of carrying out the objects of the Trust in immovable properties, shares, or debentures of Governments controlled companies, Government, Securities, deposits in Scheduled Banks or Limited Companies with power to the Trustee to vary such investments from time to time into other or others of the same nature.

11) The Trustees shall be entitled to sell by public auction or by private treaty, as they may deem proper, any immovable properties forming part of the Trust upon such terms and conditions as they may deem proper and beneficial to the Trust.

12) The Trustees shall have power to raise loans or obtain advances for the purpose of the trust with or without security and upon such terms and conditions as they deem property.





19) The term of office of the Trustees shall not exceed five Years from the date of his acceptance of the trusteeship, provided however that he shall be eligible for re-appointment as Trustees and the rights, powers and duties assigned to the existing Trustees or Trustee or Trustees will also be vested in the Trustees or Trustee jointly and severally with the surviving or continuing Trustees or Trustee. Every new Trustee appointed as aforesaid shall have the same powers, authorities and discretions and shall in all respects act as in he had been originally appointed trustee under these presents.

20) Whenever any Trustee resigns, dies or become insolvent or insane or is convicted of a criminal offence involving moral turpitude or desires to be discharged from or refuse or becomes unfit or incapable of acting, then in every case, the surviving or the continuing trustees or Trustee for time being shall be entitled to appoint a Trustee in the place of such trustees becoming insolvent or being convicted.

**Planned Amendments for future:**

- To purchase and establish old age home for poor older people by the contribution of SHG members guided by RDO or local donations or by the financial assistance of National or International agencies.

i) **Additional Main Objectives of the Organisation**

  - ii. The activities of the trust will not be carried out outside of India.
  - iii. To create awareness against Child sex abuse, Child labour, Child health etc.

  - vi. To conserve and promote child education rights and eradicate child slave.

  - ix. To organize STD/HIV/AIDS/Family planning/pulse polio/ filarial eradication / women and child care and other health, hygiene related programmes exclusively for child and women health.






- x. To build up solidarity, integrity, unity cooperation among the people of india.
